The purpose of this modification is to obligate funding under FIN PLAN 100, November 2022. Req #23CF000025 obligates \$348,469,680.66 of SPP appropriated funds and obligates \$2,238,053.23 for SPP non-appropriated funds for a total obligation of \$350,707,733.89 SPP funds. Total obligation is increased from \$18,686,880,526.54, by \$350,707,733.89 to \$19,037,588,260.43. The total Contract value of \$27,180,000,000.00 remains unchanged.
