The purpose of this modification is to issue a unilateral change order adding work scope to Sections C.8.3.05 Worker Safety and Health and C.8.3.12 Radiation Protection. This revision is being made under the authority of contract clauses B.15 *Advance Understanding – Changes to Cost and Fee* and I.100 52.243-2 *Changes – Cost Reimbursement (Aug 1987) – Alt II and III (Apr 1984)*.

Effective March 2, 2020, the Contractor is authorized a not to exceed (NTE) amount of \$500K in direct costs for the work under this modification (per Contracting Officer letter CLN200717 dated March 2, 2020). This amount is in addition to the \$15K previously authorized for development of the estimate. Funding for this NTE is currently available to support this action. The NTE does not include the overhead allocation from CLIN-1. Fluor Idaho shall invoice fully burdened costs. Once negotiations are finalized, the contract will be revised accordingly as part of the definitized modification. The cost and schedule estimate shall comply with all applicable terms of the contract including but not limited to Section B.15 *Advance Understanding – Changes to Cost and Fee* and Section I.101, 52-243-6 *Change Order Accounting (Apr 1984)*. This NTE is subject to Section B.12 *Obligation and Availability of Funds*.

The issuance of this modification confirms the change order issued by Contracting Officer letter CLN200717 dated March 2, 2020. This letter, which includes the scope of work, is incorporated with this modification.
